ORDER TRANSFERRING CERTIFICATE

(Issued July 12, 2002)

On July 12, 2001, OneStar Communications, LLC (OneStar), One Star Long Distance, Inc. (One Star Long Distance), and CRG International, Inc. (Network One), filed with the Utilities Board (Board) a notification of the transfer of assets from OneStar Long Distance and Network One to OneStar. The filing was identified as Docket No. SPU-01-9. The transfer of assets included the transfer of OneStar Long Distance's certificate of convenience and necessity to provide local exchange service, Certificate No. 0216, granted in Docket No. TCU-00-17, to OneStar. The Board granted the joint request on August 20, 2001.

On June 20, 2002, OneStar Long Distance filed a request to transfer Certificate No. 0216, issued to OneStar on August 20, 2001, back to OneStar Long Distance. In support of its request, OneStar Long Distance states that the contemplated transaction which precipitated the joint filing on July 12, 2001, was dissolved as Network One has ceased operations and will not contribute its assets to

OneStar. Consequently, OneStar never materialized and did not offer any telecommunications services to Iowa customers.

Iowa Code § 476.29(3) authorizes the transfer of a certificate upon approval by the Board. The Board has reviewed the information submitted by OneStar Long Distance and finds the necessary technical, financial, and managerial ability to provide local exchange service has been demonstrated. The Board finds it is in the public interest to approve the transfer of the certificate of public convenience and necessity of OneStar to OneStar Long Distance and that no customers will be affected by the transfer.

IT IS THEREFORE ORDERED:

1. The request for the transfer of the certificate of public convenience and necessity, identified as Certificate No. 0216, from OneStar Communications, LLC, to One Star Long Distance, Inc., filed on June 20, 2002, is approved as described in this order.

2. An amended Certificate No. 0216 is issued to OneStar Long Distance, Inc., concurrently with this order. Under this certificate, OneStar Long Distance, Inc.,

will be allowed to provide local exchange service as shown by OneStar Communications, LLC's tariff, identified as TF-01-222, as currently and subsequently approved.
