ORDER GRANTING MOTION TO WITHDRAW AND SUBSTITUTE EXHIBIT

(Issued March 5, 2007)

On February 19, 2007, the cities of Everly, Kalona, Rolfe, Terril, Titonka, and Wellman, Iowa (collectively, Cities), filed with the Utilities Board (Board) a motion to withdraw and substitute an exhibit. The Cities stated in their motion that they had contacted the other parties to these proceedings, Interstate Power and Light Company, the Consumer Advocate Division of the Department of Justice, and MidAmerican Energy, and that none of the parties resist the motion.

In support of the motion, the Cities state that on December 1, 2006, they filed prepared direct testimony in each individual docket, which included Exhibit No. ____ (LRE-3/RJL-3). The Cities on January 19, 2007, filed a corrected and substituted Exhibit No. ____ (LRE-3/RJL-3) (which excluded certain portions of the December 1, 2006, filing) applicable to each case. The Cities again filed an amended Exhibit No. ____ (LRE-3/RJL-3) on February 19, 2007, to reflect use of an updated Handy-Whitman index. The Cities want to withdraw the December 1, 2006, and January 19, 2007, copies of Exhibit No. ____ (LRE-3/RJL-3) and replace them with the February 19, 2007, version of Exhibit No. ____ (LRE-3/RJL-3). The Cities state this will result in each docket having one complete and corrected version of the exhibit.

The Board will grant the motion. The prior copies of Exhibit No. ____ (LRE-3/RJL-3) will be deemed withdrawn and replaced by the February 19, 2007, version of the exhibit.

IT IS THEREFORE ORDERED:

The "Motion to Withdraw and Substitute Exhibit" filed by the cities of Everly, Kalona, Rolfe, Terril, Titonka, and Wellman, Iowa, on February 19, 2007, is granted.
