ORDER GRANTING MOTION TO EXTEND TIME

(Issued March 30, 2007)

On March 22, 2007, Qwest Communications Corporation (QCC) filed with the Utilities Board (Board) a motion requesting an extension of time to respond to a motion for summary judgment filed in this docket by Reasnor Telephone Company, LLC (Reasnor), on March 13, 2007.

In support of its motion, QCC states that pursuant to 199 IAC 7.12, a response to Reasnor's summary judgment motion is due on or before March 27, 2007. QCC states that it propounded discovery requests to Reasnor on March 7, 2007, and QCC has not yet received Reasnor's responses, which QCC asserts are necessary to answer and rebut allegations made in Reasnor's motion. QCC also states that counsel for Reasnor has indicated that Reasnor has no objection to an extension of time. QCC asks the Board to extend the date for response to April 13, 2007.

The Board has reviewed QCC's request and finds that it is reasonable and should be granted.

IT IS THEREFORE ORDERED:

1. The motion for extension of time filed by Qwest Communications Corporation (QCC) on March 22, 2007, is granted.
2. Qwest Communications Corporation's response to the "Motion for Summary Judgment" filed by Reasnor Telephone Company, LLC, on March 12, 2007, is due on or before April 13, 2007.
