ORDER GRANTING ADMISSION PRO HAC VICE

(Issued April 19, 2007)

On March 12, 2007, Lawrence P. McLellan, an Iowa attorney representing Reasnor Telephone Company, LLC (Reasnor), in this proceeding, filed with the Utilities Board (Board) requests to allow out-of-state attorneys Tony S. Lee and James U. Troup to appear as attorneys on behalf of Reasnor in this proceeding. In

support of his requests, Mr. McLellan states that Mr. Lee is licensed to practice law in Maryland and the District of Columbia; Mr. Troup is licensed to practice law in Virginia and the District of Columbia, and that both are members in good standing of the bars of those jurisdictions.

The requests appear to be in full compliance with 199 IAC 7.2(7)"e" and include the written appearance of an Iowa-resident attorney upon whom service may be made in all matters connected with this case pursuant to Iowa Supreme Court rule 31.14.
