ORDER DOCKETING TARIFF AND SETTING RESPONSE DEADLINE

(Issued September 25, 2007)

On September 7, 2007, Interstate Power and Light Company (IPL) filed with the Utilities Board (Board) a proposed electric tariff, identified as TF-07-158. The proposed tariff is a third-step equalization tariff that would take another step toward equalizing rates across IPL's four pricing zones; if the third-step equalization tariff is implemented, prices for large general service and lighting classes will be fully equalized and prices for the residential and general service classes will have two additional steps to complete the equalization process as currently scheduled. IPL stated the proposed rate changes are designed to be revenue neutral with respect to IPL's total revenues. Consistent with prior equalization filings, IPL has proposed a June 30, 2008, effective date for the third-step equalization tariff.

In the Board's "Final Decision and Order" issued January 14, 2005, in Docket No. RPU-04-1, the Board directed IPL to begin making annual, revenue-neutral equalization filings. Tariff filing TF-07-158 is the third of these annual filings that have generally been referred to as rate equalization filings.

The Board has not completed its review of the proposed tariff. To allow the Board and other interested persons time to fully consider the proposed third step in

rate equalization, the tariff will be docketed as a formal contested case proceeding, identified as Docket No. RPU-07-4. However, a procedural schedule will not be established at this time. The Board will allow interested persons to file comments or objections to the proposed tariff on or before October 12, 2007. If no objections to the proposed tariff are filed, the Board will proceed to rule on the tariff without hearing or further comment period. If objections are filed, the Board will set a procedural schedule.

IT IS THEREFORE ORDERED:

1. An investigation is instituted pursuant to Iowa Code chapter 476 to determine the reasonableness of Interstate Power and Light Company's electric rate schedules and tariff filed on September 7, 2007. This matter will be identified as Docket No. RPU-07-4, a formal contested case proceeding. Tariff filing TF-07-158 is suspended. The expenses reasonably attributable to this investigation shall be assessed to IPL in accordance with Iowa Code § 476.10.

2. Interested persons may file comments or objections on or before October 12, 2007.
