**PIPELINE PERMIT**

(Issued December 28, 2007)

Permit No. 1231 Lateral VeraSun Hartley Ethanol Plant

Permission is hereby granted to Aquila, Inc., d/b/a Aquila Networks (Aquila), to construct, operate, and maintain pipelines in Clay and O'Brien Counties, Iowa, for the transportation of natural gas at a maximum operating pressure of 800 psig for approximately 7.13 miles over the route attached to and incorporated by reference in this permit.

Permit No. 1231 is granted subject to the provisions of Iowa Code Chapter 479 (2007), 199 Iowa Administrative Code Chapters 9 and 10 (2007), and the December 18, 2007, "Proposed Decision and Order Granting Permit" issued in this docket.

Permit No. 1231 shall be effective until December 28, 2032, unless revoked, terminated, or amended by the Utilities Board.

NORTHERLY TERMINUS: HIGH PRESSURE VALVE LOCATED ON VERASUN'S PROPERTY IN THE SOUTHEAST  $\frac{1}{4}$  OF SECTION 31, TOWNSHIP 97 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M., O'BRIEN COUNTY, IOWA.

SOUTHERLY TERMINUS: NORTHERN NATURAL GAS METER STATION LOCATED IN THE SOUTHEAST  $\frac{1}{4}$  OF SECTION 18, TOWNSHIP 96 NORTH, RANGE 38 WEST OF THE 5<sup>TH</sup> P.M., CLAY COUNTY, IOWA.

BEGINNING AT THE SOUTHERLY TERMINUS, POINT BEING A NORTHERN NATURAL GAS METER STATION ON THE NORTH SIDE OF 360<sup>TH</sup> STREET IN THE SOUTHEAST  $\frac{1}{4}$  OF SECTION 18, TOWNSHIP 96 NORTH, RANGE 38 WEST OF THE 5<sup>TH</sup> P.M., CLAY COUNTY, IOWA; THENCE NORTHWESTERLY THROUGH THE SOUTHWEST  $\frac{1}{4}$  OF SAID SECTION 18; THENCE CONTINUING NORTHWESTERLY CROSSING 100<sup>TH</sup> AVENUE AND THROUGH THE SOUTHEAST  $\frac{1}{4}$ , THE NORTHEAST  $\frac{1}{4}$  AND THE NORTHWEST  $\frac{1}{4}$  OF SECTION 13, TOWNSHIP 96 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M., O'BRIEN COUNTY, IOWA TO A POINT BEING APPROXIMATELY 15 FEET WEST OF THE EAST LINE OF SAID NORTHWEST  $\frac{1}{4}$ ; THENCE NORTH ALONG A LINE APPROXIMATELY 15 FEET WEST OF AND PARALLEL WITH THE EAST LINE OF SAID NORTHWEST  $\frac{1}{4}$  TO A POINT IN THE SOUTH RIGHT OF WAY OF 350<sup>TH</sup> STREET; THENCE WEST IN SAID NORTHWEST  $\frac{1}{4}$  AND IN SAID SOUTH RIGHT OF WAY APPROXIMATELY 1900 FEET; THENCE NORTHWESTERLY CROSSING 350<sup>TH</sup> STREET AND THROUGH THE SOUTHWEST  $\frac{1}{4}$  OF SECTION 12, TOWNSHIP 96 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M.; THENCE CONTINUING NORTHWESTERLY CROSSING YEW AVENUE AND THROUGH THE SOUTHEAST  $\frac{1}{4}$ , SOUTHWEST  $\frac{1}{4}$  AND NORTHWEST  $\frac{1}{4}$  OF SECTION 11, TOWNSHIP 96 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M.; THENCE CONTINUING NORTHWESTERLY CROSSING WILSON AVENUE AND THROUGH THE NORTHEAST  $\frac{1}{4}$  OF SECTION 10, TOWNSHIP 96 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M.; THENCE CONTINUING NORTHWESTERLY CROSSING 340<sup>TH</sup> STREET AND THROUGH THE SOUTHEAST  $\frac{1}{4}$  AND THE SOUTHWEST  $\frac{1}{4}$  OF SECTION 3, TOWNSHIP 96 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M.; THENCE CONTINUING NORTHWESTERLY CROSSING WHITE AVENUE AND THROUGH THE SOUTHEAST  $\frac{1}{4}$ , NORTHEAST  $\frac{1}{4}$  AND NORTHWEST  $\frac{1}{4}$  OF SECTION 4, TOWNSHIP 96 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M., THENCE CONTINUING NORTHWESTERLY TO A POINT IN THE NORTH HALF OF 330<sup>TH</sup> STREET RIGHT OF WAY, POINT BEING IN THE SOUTHWEST  $\frac{1}{4}$  OF SECTION 33, TOWNSHIP 97 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M.; THENCE WESTERLY IN SAID NORTH HALF OF 330<sup>TH</sup> STREET RIGHT OF WAY THROUGH SAID SOUTHWEST  $\frac{1}{4}$  OF SECTION 33; THENCE CONTINUING WESTERLY IN SAID NORTH HALF OF 330<sup>TH</sup> STREET RIGHT OF WAY CROSSING WARBLER AVENUE AND WALNUT AVENUE AND THROUGH THE SOUTHEAST  $\frac{1}{4}$  AND SOUTHWEST  $\frac{1}{4}$  OF SECTION 32, TOWNSHIP 97 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M.; THENCE CONTINUING WESTERLY IN SAID NORTH HALF OF 330<sup>TH</sup> STREET RIGHT OF WAY CROSSING VINE AVENUE AND THROUGH THE SOUTHEAST  $\frac{1}{4}$  OF SECTION 31, TOWNSHIP 97 NORTH, RANGE 39 WEST OF THE 5<sup>TH</sup> P.M. TO THE NORTHERLY TERMINUS, A HIGH PRESSURE VALVE LOCATED ON VERASUN'S PROPERTY, SAID LINE BEING APPROXIMATELY 37,665 FEET IN LENGTH.
