ORDER GRANTING MOTION TO EXTEND RESPONSE DEADLINE

(Issued January 11, 2008)

On January 4, 2008, Reasnor Telephone Company, LLC (Reasnor), filed with the Utilities Board (Board) a motion to compel answers to written discovery

propounded upon Qwest Communications Corporation (QCC). Pursuant to the Board's order issued May 25, 2007, in this proceeding, QCC has five business days in which to file its response to Reasnor's motion. Therefore, QCC's response is due on or before January 11, 2008.

On January 9, 2008, QCC filed an unopposed motion to extend the deadline for response to Reasnor's motion to compel. QCC states that its counsel is involved in depositions in the days immediately preceding January 11 and, as such, requests an extension of three business days in which to file its response.

The Board has considered QCC's request and finds that it is reasonable. QCC may file its response to Reasnor's motion to compel on or before January 16, 2008.

IT IS THEREFORE ORDERED:

1. The motion to extend deadline for response filed by Qwest Communications Corporation on January 9, 2008, is granted.
2. Qwest Communications Corporation may file a response to the motion to compel filed by Reasnor Telephone Company, LLC, on or before January 16, 2008.
