

**Interstate Power and Light Company (subsidiary of Alliant Energy)  
Proposed Electric and Natural Gas Rate Increases  
Docket No. RPU-2023-0002**

**Application Filed with the Iowa Utilities Board (IUB):** October 12, 2023

**What Alliant Energy is Requesting from the IUB:**

- An increase in electric service revenue of \$284 million, or approximately 16 percent above their existing electric revenue requirement.
- An increase in natural gas service revenue of approximately \$14 million, or 5 percent above their existing gas revenue requirement.

**Role of the IUB and Parties in a Rate Case Proceeding:** The obligation of the IUB under Iowa law is to ensure that the requested rate charges made by any public utility within the rate case are just and reasonable. A procedural schedule and public hearing date will be established by the IUB. The IUB will preside over the public hearing, which is required under Iowa law. The Office of Consumer Advocate (OCA), a division of the Iowa Department of Justice, is a party to all IUB proceedings. The OCA does not represent any individual customer or specific class of customers in rate cases, but examines the rate proposal to determine the justification of the request. Those who may be affected by the utility's proposed rate change are allowed to file a petition to intervene.

**Timeframe for Decision:** Iowa law sets timeframes for this type of proceeding. A final decision is generally rendered within ten months after the rate case application filing date.

**About Consumer Comment Meetings:** The IUB is permitted to hold consumer comment meetings as part of a rate case proceeding to provide an opportunity for customers of a utility to express their views regarding the rate case, as well as the general quality of service provided by the utility. The IUB and OCA attend, and representatives from the utility present the utility's proposal and respond to questions.

**Making Public Comments in a Rate Case Proceeding:** Customers have the right to file written comments and objections with the IUB that include any facts that would assist the IUB in reviewing the proposed rate adjustment and have the right to request a public hearing regarding the proposed new rates.
