COMES NOW Respondent Iowa Utilities Board, by and through its undersigned counsel, pursuant to Iowa Rules of Civil Procedure 1.1602, and Iowa Code § 17A.19(6), and for its Motion to Enlarge Time to Transmit Certified Record, respectfully states as follows:

1. On March 24, 2021 and in the above-captioned docket, Petitioner Linda Juckette (“Ms. Juckette”) filed a Petition for Judicial Review from final agency action taken by Respondent Iowa Utilities Board (the “Board”).
2. Upon information and belief and as a result of discussions with Ms. Juckette’s counsel, the undersigned understands that Ms. Juckette intends to file an amended and substituted petition.
3. Iowa Code § 17A.19(6) permits the district court to enlarge the time by which the agency must transmit to the reviewing court a certified copy of the entire contested case record.
4. The Board respectfully requests the Court enlarge the time to transmit the agency record to May 10, 2021, or to 30 days following the filing of an amended and substituted petition, whichever occurs later. The Board will file an Answer within 20 days from the filing an amended and substituted petition.

5. The undersigned spoke with Ms. Juckette's attorney, who authorized the undersigned to state that Respondent has no objection to the Board's request to enlarge the time to transmit the certified record.

WHEREFORE, Respondent Iowa Utilities Board respectfully requests this Court grant the above-captioned motion and extend the deadline to transmit the agency record to May 10, 2021, or to 30 days following the filing of an amended and substituted petition, whichever occurs later. Respondent Iowa Utilities Board requests such relief as may be just and equitable under the circumstances.
