This matter comes before the court upon the motion for leave to file an amicus curiae brief filed by the Coalition of MISO Transmission Customers, and the application for pro hac vice admission of attorney Kenneth R. Stark filed pursuant to Iowa Court Rule 31.14 and Iowa Rule of Electronic Procedure 16.304(1)(b)(1).

Upon consideration, the court grants the motion for leave to file an amicus curiae brief and accepts the brief filed on September 30, 2021. The application for pro hac vice admission of attorney Kenneth Stark is also granted.

Pro hac vice counsel is advised that this appeal is governed by Chapter 16 of the Iowa Court Rules pertaining to the court's electronic document management system. Pursuant to rule 16.304(1)(b)(1) out-of-state lawyers admitted pro hac vice are to complete the EDMS registration process. The clerk shall provide a personal identification number to

an attorney who has not yet registered. Counsel will need to use the personal identification number to properly register. Pro hac vice counsel is reminded that in the application pro hac counsel agreed to be served through local counsel. Until counsel is properly registered, counsel shall be served with copies of orders and other filings through local counsel.

Please be advised that in the event oral argument is granted in this case, in-state counsel must be present for oral argument when an out-of-state attorney who has been admitted pro hac vice intends to present the oral argument before the court. *See* Iowa Ct. Rs. 31.14(2)(a), 31.14(3).
